We thank those parents that have already registered at St. Brigid~St. Frances Cabrini Catholic Academy. As of March 11, 2019, 40 students from St. Frances Cabrini Catholic Academy have been registered.

As we continue with the merger process for St. Brigid and St. Frances Cabrini, we wanted to provide you with another set of questions that have surfaced since our last communication.

Is There Still Time to Apply for a Scholarship through Futures in Education?

Yes! Applications must be submitted by the scholarship deadlines as follows:

March 29, 2019– Returning Families who received an award in the previous academic year.

April 29, 2019– New families (did not receive an award in previous academic year).

Please note that applications will only be considered completed when all required supporting documents have been submitted.

If I have an Angel Scholarship, how do I get that scholarship transferred?

Per the response above, please submit your scholarship application.

Returning families will be awarded within the same program as in the previous year provided the household financial situation remains the same.

What is the status of Bus Transportation for the Students?

Given that we already have 40 students registered from St. Frances Cabrini Catholic Academy registered at St. Brigid~St. Frances Cabrini Catholic Academy, we can begin

the process to establish Bus Routes through the New York City Office of Pupil Transportation.

Will St. Brigid~St. Frances Cabrini Catholic Academy have a Full Time Nurse?

Yes, a full-time nurse will be assigned to the Academy.

Will St. Brigid~St. Frances Cabrini Catholic Academy have an After-School Program?

Yes, there will be an After-School Program at the Academy. We are working on these services for the Students.

Will there be a Summer School Program?

We are working to provide all students with a Summer School Program. Details regarding the Summer School Program will be sent in the next update.

Will there be After School Enrichment Programs?

We will be working with the Faculty to develop After School Enrichment Programs to begin in the Fall of 2019.

Will St. Brigid~St. Frances Cabrini Catholic Academy have the same Academic and Educational Services?

All Academic and Educational Programs will be merged into the Academy. We will continue to support all the educational needs of the students.

Will Breakfast and Lunch from the New York City Food Services be provided?

Yes, we will continue to provide the food services through the New York City Food Program.

What Building Repairs are needed?

The Building at St. Brigid Catholic Academy needs minor updates including front doors, updated water fountains, general painting and regularly scheduled updates to the infrastructure.

When we will know about the Faculty and Staff?

The process to begin the hiring process of Administration, Faculty and Staff will begin within the next week.

The Administration, Faculty and Staff will be announced prior to Easter.

**When will Registration Close at St. Brigid~St. Frances Cabrini Catholic Academy
Close?**

While registration is ongoing, we would like to close registration by March 31, 2019.

By closing registration on March 31, 2019, we will be able to hire Faculty and formally announce the Faculty before Easter.
